Independent Accountants' Report on Applying Agreed-Upon Procedures

We have performed the procedures enumerated below, which were agreed to by the Ohio Department of Medicaid (ODM), on Dr. Thomas M. Mahany's (hereafter referred to as the Provider) compliance with the requirements of the Medicaid Provider Incentive Program (MPIP) for the year ended December 31, 2015. The Provider is responsible for compliance with the MPIP requirements. The sufficiency of these procedures is solely the responsibility of ODM. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below either for the purpose for which this report has been requested or for any other purpose.

- 1. We compared the Provider's Ohio Medicaid Agreement dates from the Medicaid Information Technology System to the patient volume attestation period. We found the Provider had an active agreement in effect during this period.
- 2. Using the Ohio e-license center, we compared the licensure type and effective dates to the patient volume attestation period. We found no exceptions.
- 3. Using the MPIP system, we confirmed the Provider underwent the ODM's payment approval process, was approved for an incentive payment and received an incentive payment.
 - We compared the date of the payment approval with the date of the incentive payment and confirmed the payment approval occurred prior to the payment. In addition, we compared the payment amount with the MPIP payment schedule and found no variance.
- 4. We obtained the Provider's encounters during the patient volume attestation period. We scanned this list and found duplicate encounters. We removed duplicates and recalculated encounters. We also scanned the list and found it included multiple payer sources.
- 5. We recalculated the Medicaid patient volume from the Provider's adjusted encounters identified in procedure 4 and confirmed the Provider met the 30 percent patient volume requirement.
- 6. We found the Provider's location was now using a newer version of the electronic health record (EHR) software reported in the MPIP system. We verified that the newer version of the EHR software was approved by the Office of the National Coordinator of Health IT.
- 7. We could not determine if the meaningful use summary report contained encounters from all locations identified on the Provider's list of locations as we received no unique patient data reports, see procedure 8. We did compare the Provider's list of two locations to the patient volume encounter report to determine if all locations were included. We found no differences.

- 8. We obtained a meaningful use summary report for the 10 objectives and compared it to the applicable criteria. We found no exceptions. We were unable to scan the detailed data for two measures that require only unique patients be counted as we did not received detailed data from the Provider.
- We obtained supporting documentation for the clinical quality measures and compared it to the applicable criteria. We confirmed that the minimum number of measures was met with at least one measure from three different domains.

Responsible Party's Written Representation:

The Provider declined to submit a signed representation letter acknowledging responsibility for maintaining records and complying with applicable MPIP regulations; making available all documentation related to compliance; responding fully to our inquiries; reporting any non-compliance subsequent to the end of the engagement period; and disclosing all communications received from regulatory agencies alleging noncompliance with the Ohio MPIP rules.

This agreed-upon procedures engagement was conducted in accordance with the American Institute of Certified Public Accountants' attestation standards. We were not engaged to and did not conduct an examination or review, the objective of which would be the expression of an opinion or conclusion, respectively, on the Provider's compliance with the requirements of the Medicaid Provider Incentive Program. Accordingly, we do not express such an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported. This report is intended solely for the information and use of the Provider and the ODM, and is not intended to be, and should not be used by anyone other than the specified parties.
