REPORT OF INDEPENDENT ACCOUNTANTS

To the Mahoning County Democratic Organization Central & Executive Committee:

We have performed the procedures enumerated below, which were agreed to by the Treasurer, solely to comply with the requirements of Section 3517.17 of the Ohio Revised Code. This engagement to apply agreed-upon procedures was performed in accordance with standards established by the American Institute of Certified Public Accountants. The sufficiency of the procedures is solely the responsibility of the specified users of the report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

The procedures and associated findings are as follows:

CASH RECEIPTS

1. We confirmed the Ohio Political Party Fund receipts with the State of Ohio and agreed to amounts shown on the Political Party Public Funds Report.

We noted that the Ohio Political Party Fund receipt dated 1/13/00 in the amount of \$67.67 was received but never cashed. We also noted that the Ohio Political Party Fund receipt dated 10/12/00 in the amount of \$419.23 was not received by the party treasurer. We recommend that the Treasurer take steps to have these checks reissued.

CASH RECONCILIATION

1. We compared the sum of the cash balances recorded on the Democratic Party's Political Party Public Funds Report with cash balances recorded on the bank reconciliation for the Democratic Party as of 12/31/00. We recomputed the mathematical accuracy of the reconciliation.

We found no exceptions as a result of our procedures.

CASH DISBURSEMENTS

- 1. We confirmed the mathematical accuracy of the cash disbursement listing and compared the listing totals to the disbursement totals on the Political Party Public Funds Report.
- 2. We traced selected recorded disbursements to source documentation such as canceled checks. We also determined that the checks were signed by authorized signatories and endorsed by the
- 3. We reviewed selected disbursement transactions for compliance with Section 3517.18 of the Ohio Revised Code.

We found no exceptions as a result of our procedures.
