Independent Accountants' Report on Applying Agreed-Up Procedures

We have performed the procedures enumerated below, which were agreed to by the Ohio Department of Medicaid (ODM), on Heather R. Howard's (hereafter referred to as the Provider) compliance with the requirements of the Medicaid Provider Incentive Program (MPIP) for the year ended December 31, 2016. The Provider is responsible for compliance with the MPIP requirements. The sufficiency of these procedures is solely the responsibility of ODM. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below either for the purpose for which this report has been requested or for any other purpose.

1. We obtained the Provider's encounters during the patient volume attestation period. We scanned the list and found duplicate encounters. We removed duplicates and recalculated encounters. We also found it included multiple payer sources.
2. We recalculated the Medicaid patient volume from the encounters identified in procedure 1 and confirmed the Provider met the 30 percent patient volume requirement.
3. We found that the electronic health record (EHR) system reported in the MPIP system is no longer in use. We did not obtain any supporting documentation of the electronic health record (EHR) system currently in use as the practice has closed.
4. We obtained the Provider's location list which identified two locations; however, the meaningful use report did not identify any locations. We selected 10 patient names from the patient volume report during the meaningful use period and traced the names to the meaningful use report. We found no differences.
5. We obtained supporting documentation for the 10 objectives and compared it to the applicable criteria. We found that objective 6 did not meet the applicable criteria. We found no other exceptions.

For those measures that require only unique patients be counted, we scanned the detailed data and found no duplicates.

6. We obtained supporting documentation for the clinical quality measures and compared it to the applicable criteria. We confirmed the minimum number of measures was met with at least one measure from three different domains.
