## Independent Accountants' Report on Applying Agreed-Upon Procedures

We have performed the procedures enumerated below, which were agreed to by the Ohio Department of Medicaid (ODM), on Dr. Mandelik's (hereafter referred to as the Provider) compliance with the requirements of the Medicaid Provider Incentive Program (MPIP) for the year ended December 31, 2016. The Provider is responsible for compliance with the MPIP requirements. The sufficiency of these procedures is solely the responsibility of ODM. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below either for the purpose for which this report has been requested or for any other purpose.

1. We obtained the Provider's encounters during an alternate patient volume attestation period (September 1, 2016 to November 30, 2016). We scanned the list and found duplicate encounters. We removed duplicates and recalculated encounters. We also found it included multiple payer sources.
2. We recalculated the Medicaid patient volume from the encounters identified in procedure 1 and confirmed the Provider met the 30 percent patient volume requirement.
3. We found that the location where the Provider worked was now using a newer version of the electronic health record (EHR) software reported in the MPIP system. We found that the newer version of the EHR software was approved by the Office of the National Coordinator of Health IT.
4. We obtained the Provider's equipped practice location(s) during the meaningful use period and compared this to the locations included in the meaningful use report. We found no exception.
5. We obtained supporting documentation for the 10 objectives and compared it to the applicable criteria. We found no exceptions; however, the Provider stated that the meaningful use attestation period only included two months of meaningful use data which does not meet the continuous 90 day requirement for the 2016 EHR reporting period per 42 CFR 495.4 (2)(D)

We could not perform a scan of the detailed data for those measures that require only unique patients be counted as the Provider did not provide any unique patient data.

6. We obtained supporting documentation for the clinical quality measures (CQM) and compared it to the applicable criteria. We confirmed the minimum number of measures was met with at least one measure from three different domains; however, the CQM period is not for a continuous 90 day period, see procedure 5.
