Report of Independent Accountants

To Dr. Kristina M. Johnson, President The Ohio State University

We have performed the procedures enumerated below, which were agreed to by the Chief Financial Officer and Senior Vice President for Business and Finance of The Ohio State University (the "University"), related to whether the accompanying Statement of Receipts and Disbursements for Affiliated and Outside Organizations Acting on Behalf of the Department of Athletics of the University for the year ended June 30, 2020 (the "Statement") is in compliance with the National Collegiate Athletic Association ("NCAA") Bylaw 3.2.4.17 for the year ended June 30, 2020. Management of the University is responsible for the Statement and the compliance with the NCAA requirements. The sufficiency of these procedures is solely the responsibility of the parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

The procedures performed and results thereof are as follows:

- 1. We obtained from University management a list of all University booster group activities, for both independent and affiliated organizations (including alumni organizations), that have a principal purpose of generating funds for the University's Department of Athletics, during the year ended June 30, 2020. The procedures listed below were performed for all organizations identified by management as having been active for all or a portion of the fiscal year ended June 30, 2020. Refer to the schedule below for a listing of the organizations and the results of the procedures performed.
 - A. We obtained the financial statements for affiliated organizations as of June 30, 2020 and agreed each of the revenue and expense amounts appearing in the financial statements of the affiliated organizations to the corresponding amounts included in the Statement.

No exceptions were noted as a result of performing this procedure.

B. For each organization on the listing, we electronically sent confirmations directly to the officials of each organization requesting they confirm the revenue and expense amounts included in the Statement.

No exceptions were noted as a result of performing this procedure.

C. We obtained a representation letter signed by the Director of Athletics and each of the 30 head coaches of the men's and women's varsity sports programs that the booster groups, as listed below, are the only booster groups that support the Department of Athletics as defined in the National Collegiate Athletic Association ("NCAA") Financial Audit Guidelines.
