We have completed certain procedures in accordance with Ohio Rev. Code Section 117.01(G) to the accounting records and related documents of the Englewood Community Improvement Corporation, Montgomery County, (the Corporation) for the years ended December 31, 2022 and 2021.

Our procedures were designed solely to satisfy the audit requirements of Ohio Rev. Code Section 117.11(A). Because our procedures were not designed to opine on the Corporation's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the Corporation's financial statements, transactions or balances for the years ended December 31, 2022 and 2021.

The Corporation's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code Section 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found no significant compliance or accounting issues to report.

### Current Status of the Matters Reported in our Prior Engagement

Our prior audit for the years ended December 31, 2020 and 2019 included an observation that the Corporation did not have a Public Records Policy or a Records Retention Schedule. The Corporation established a Public Records Policy and a Records Retention Schedule during the years ended December 31, 2022 and 2021.

Our prior audit for the years ended December 31, 2020 and 2019 also included an observation that the Corporation did not notify the public of the dates of scheduled meetings. The Corporation notified the public of the dates of schedule meetings on their website during the years ended December 31, 2022 and 2021.
