INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

Republican Executive Committee Meigs County P.O. Box 469 Pomeroy, Ohio 45769

To the Executive Committee:

We have performed the procedures enumerated below, which were agreed to by the Republican Executive Committee, Meigs County, Ohio (the Committee), solely to assist the Committee in evaluating its compliance with Sections 3517.17 and 3517.18 of the Ohio Revised Code for the year ended December 31, 2002. Management is responsible for the Committee's compliance with those requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements. The sufficiency of the procedures is solely the responsibility of the Executive Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Cash Receipts

We confirmed the Ohio Political Party Fund receipts with the State of Ohio and agreed them to amounts shown on the Ohio Campaign Finance Report. A receipt from the State of Ohio, in the amount of \$8.81 was received after the Ohio Campaign Finance Report was prepared and accounted for in The Committee's record. The Committee's accompanying Ohio Campaign Finance Report has been adjusted to reflect this receipt.

Cash Reconciliation

- 1. We compared the sum of the cash balances recorded on the Committee's adjusted Ohio Campaign Finance Report with the cash balances reconciled by the Committee as of December 31, 2002. The sums agreed.
- 2. We recomputed the mathematical accuracy of the reconciliation. We found no computational errors.
- 3. We agreed bank balances on the reconciliation with month end bank statements. The amounts agreed.

Cash Disbursements

- 1. We footed the cash disbursement listing the Statement of Expenditures and compared the listing totals to the disbursement totals on the Ohio Campaign Finance Report. The amounts agreed.
- 2. We compared the purpose for the disbursement with the allowable uses described in Section 3517.18 of the Ohio Revised Code. We found no exceptions.

Cash Disbursements (Continued)

- 3. We agreed the disbursement transaction and the payee to the canceled check and invoices. The payees and amounts recorded in the cash disbursement listing agreed to the payees and the amounts on the canceled checks.
- 4. We compared the signature on the check to the list of authorized signatories the Committee provided to us. We compared the endorsement to the payee listed on the check. The signatory on all checks we selected was an approved signatory.

Payroll Disbursements

There were no payroll disbursements.

We were not engaged to, and did not; perform an examination, the objective of which would be the expression of an opinion on compliance of the Ohio Campaign Finance Report which is attached to this report. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that we would have reported to you.

This report is intended solely for the information and use of the Executive Committee and is not intended to be and should not be used by anyone else.
