### **INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES**

We have performed the procedures enumerated below, which were agreed to by the Democratic Executive Committee, solely to assist the Committee in evaluating its compliance with Sections 3517.17 and 3517.18 of the Ohio Revised Code for the year ended December 31, 2003. Management is responsible for the Committee's compliance with those requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements. The sufficiency of the procedures is solely the responsibility of the Executive Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

#### **Cash Receipts**

We confirmed the Ohio Political Party Fund receipts with the State of Ohio and agreed them to amounts shown on the Political Party Fund Finance Report. We found no exceptions.

#### **Cash Reconciliation**

1. We compared the sum of the cash balances recorded on the Committee's Ohio Campaign Finance Report with the cash balances reconciled by Patricia Green for the Committee as of December 31, 2003. The sums agreed.
2. We recomputed the mathematical accuracy of the reconciliation. We found no computational errors.
3. We agreed bank balances on the reconciliation with month end bank statements. The balances agreed.
4. There were no reconciling items at December 31, 2003.

### **Cash Disbursements**

1. We footed the cash disbursement listing totals to the disbursement totals on the Political Party Fund Finance Report. The amounts agreed.
2. We traced the payee and amount to source documentation such as invoices and canceled checks. For three of the five expenditures made during the year, no original invoice could be located to support the expenditure. Each of the three expenditures without invoices were made to the postmaster for postage. We also compared the payees on the checks to the names on the invoices. The payee and check date were not recorded in the checkbook. The payees and amounts recorded in the cash disbursement journal agreed to the payees and amounts on the canceled checks.

We recommend that invoices be obtained and kept on file for all expenditures made, including those made for postage. Checks issued should be recorded in the checkbook by check number, date, amount and payee.

3. We compared the signature on the check to authorized signatories on the Committee's bank statement. The signatory on all checks we selected was an approved signatory.
4. We compared the purpose for the disbursement with the allowable uses described in Section 3517.18 of the Ohio Revised Code. We found no exceptions.

### **Payroll Disbursements**

1. There were no personnel positions paid with Ohio Political Party Fund monies during the year ended December 31, 2003.
