INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

Republican Executive Committee Wyandot County Sue Ohl, Treasurer 420 West Church Street Upper Sandusky, Ohio 43351

We have performed the procedures enumerated below, which were agreed to by the Republican Executive Committee, solely to assist the Committee in evaluating its compliance with Sections 3517.17 and 3517.18 of the Ohio Revised Code for the year ended December 31, 2003. Management is responsible for the Committee's compliance with those requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements. The sufficiency of the procedures is solely the responsibility of the Executive Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Cash Reconciliation

- 1. We compared the sum of the cash balance recorded on the Committee's Ohio Campaign Finance Report with the cash balance reconciled by the Treasurer as of December 31, 2003. The sums agreed.
- 2. We recomputed the mathematical accuracy of the reconciliation. We found no computational errors.
- 3. We agreed bank balances on the reconciliation with month end bank statements. The balances agreed.

Cash Receipts

We confirmed the Ohio Political Party Fund receipts with the State of Ohio and agreed them to amounts shown on the Ohio Campaign Finance Report. A distribution by the State of Ohio in the amount of \$12.08 dated October 11, 2002 was deposited on January 8, 2003 and, therefore, is included on the Ohio Campaign Finance Report (Exhibit 1). Also, a distribution by the State of Ohio in the amount of \$9.38 dated October 14, 2003 was not deposited by the Committee until January 5, 2004 and, therefore, does not appear on the Ohio Campaign Finance Report (Exhibit 1). No other exceptions were noted.
