**INDEPENDENT ACCOUNTANTS' REPORT ON
APPLYING AGREED UPON PROCEDURES**

We have performed the procedures enumerated below, which were agreed to by Linda Kidwell, former Treasurer, solely to assist in the transition of the Evergreen Local School District Treasurer as of November 30, 2005. This engagement to apply agreed-upon procedures was performed in accordance with standards established by the American Institute of Certified Public Accountants. The sufficiency of the procedures is solely the responsibility of the specified users of the report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report is requested or for any other purpose.

The procedures and associated findings are as follows:

Cash Reconciliation

1. We compared the sum of the cash balances Fund Summary Report for all District funds with the cash balances recorded on the bank reconciliation prepared by Deb Ford, Interim Treasurer for the Treasurer's office as of November 30, 2005. The amounts agreed.
2. We compared bank balances on the reconciliation with the month end bank statements. The amounts agreed.
3. We also agreed reconciling items appearing on the reconciliation to cancelled checks, deposit slips or other supporting documentation. The amounts on the reconciliation for cancelled checks and deposit slips agreed to the amount on the subsequent returned cancelled checks and to the amounts posted in the cash receipts ledger.
4. We also inspected depository remittance memoranda for the investment portfolio maintained by the Treasurer, for proper account name and amounts reported. The items agreed.
