INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

Secretary of State of Ohio Democratic Party Executive Committee Madison County 251 Fellows Ave West Jefferson, Ohio 43162

We have performed the procedures enumerated below, to which the Madison County Democratic Party Executive Committee (the Committee) agreed, solely to assist the Committee in evaluating its compliance with certain requirements included in Ohio Rev. Code Sections 3517.1012, 3517.13(X)(1), 2(b), (3)(a), and (4), 3517.17, and 3517.18, for the year ended December 31, 2008. The Committee is responsible for complying with these requirements. We followed the American Institute of Certified Public Accountants' attestation standards for agreed-upon procedures engagements. The sufficiency of the procedures is solely the responsibility of the Committee. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Cash Receipts

- We inquired of the Committee whether they deposited all gifts from corporations, labor organizations and all gifts restricted to operations into the same fund into which they deposit amounts received from the State Tax Commissioner. Management informed us they received no such gifts.
- 2. We footed the Statement of Political Party Restricted Fund Deposits Ohio Rev. Code Section 3517.17 requires (Deposit Form 31-CC), filed for the first half of 2008. The Committee did not file the required Form 31-CC for the second half of 2008; rather they filed the Statement of Contributions Received (Form 31-A). Therefore, we footed the Statement of Contributions Received Form 31-A), filed for the second half of 2008. We noted no computational errors.

Ohio Rev. Code Section 3517.17 requires a political party to deposit into its restricted fund all public moneys received from the Ohio Political Party Fund. Ohio Rev. Code Section 3517.10(C) (6) (b) states the secretary of state shall prescribe the form for all statements required to be filed under this section. As prescribed by the Ohio Secretary of State, the Committee is required to use the *Statement of Political Party Restricted Fund Deposits* (Form 31-CC) to report all receipts from the Ohio Political Party Fund.

The Committee used *Statement of Contributions Received (Form 31-A)* to report receipts from the Ohio Political Party for the second half of 2008. The Committee should use the latest *Statement of Political Party Restricted Fund Deposits* Form (Form 31-CC) to report receipts from the Ohio Political Party.

Cash Receipts (Continued)

3. We compared bank deposits reflected in 2008 restricted fund bank statements to total deposits recorded in Deposit Forms 31-CC filed for the first half of 2008. However, as noted in Step 2 above, the Statement of Political Party Restricted Fund Deposits Ohio Rev. Code Section 3517.17 requires (Form 31-CC) was not filed for the second half of 2008. Therefore, we compared bank deposits reflected in 2008 restricted fund bank statements to total deposits recorded in Statement of Contributions Received (Form 31-A), filed for the second half of 2008 instead.

In addition to not filing the proper form, we noted an exception; interest earned in September, in the amount of 12 cents, was not included on the receipt reports.

- 4. We scanned the Committee's 2008 bank statements and noted they reflected four quarterly payments received from the State Tax Commissioner pursuant to Ohio Rev. Code 3517.17(A). The Deposit Forms 31-CC reported the sum of the first three payments, the fourth payment was reported on the Form 31-A, without exception
- 5. We scanned other recorded 2008 receipts for evidence that a corporation or labor organization may have exceeded the \$10,000 annual gift limit Ohio Rev. Code 3517(X)(3)(a) imposes. We found no evidence that any corporation or labor organization exceeded this limit.

Cash Reconciliation

- 1. We recomputed the mathematical accuracy of the December 31, 2008 reconciliation for the bank account used for receipts and disbursements restricted pursuant to Ohio Rev. Code Section 3517.1012(A). We found no computational errors.
- 2. We agreed the bank balance on the reconciliation to the bank statement balance as of December 31, 2008. The balances agreed.
- 3. The Committee had no reconciling items in excess of \$100 appearing on the reconciliation.

Cash Disbursements

- We footed the Statement of Political Party Restricted Fund Disbursements Ohio Rev. Code Section 3517.17 requires (Disbursement Form 31-M), filed for the first half of 2008. We noted no computational errors. The Committee did not file Disbursement Form 31-M for the second half of 2008.
- 2. Per Ohio Rev. Code 3517.13(X)(1), we scanned Disbursement Form 31-M filed for 2008 and inquired of management whether they transferred any cash from the restricted fund to any other political party account into which contributions may be made or from which contributions or expenditures may be made. We found no evidence of prohibited transfers.
- 3. We compared the amounts on checks or other disbursements reflected in 2008 restricted fund bank statements to disbursement amounts reported on Disbursement Forms 31-M filed for 2008.
 - During our testing we noted the Committee did not report a bank service charge, in the amount of \$5, which was reflected on the September bank statement.
- 4. For each disbursement on Disbursement Form 31-M filed for 2008, we traced the payee and amount to payee invoices and to the payee's name on the bank issued canceled checks. The payees and amounts recorded on Disbursement Forms 31-M agreed to the payees and amounts on the canceled checks and invoices.

Cash Disbursements (Continued)

- 5. We scanned the payee for each 2008 disbursement for evidence that it might represent a contribution or campaign-related disbursement, both of which Ohio Rev. Code 3517.13(X)(2)(b) prohibit. We found no evidence that any restricted fund disbursements represented contributions or campaign-related disbursements.
- We did not compare the signature on 2008 checks to the list of authorized signatures as all disbursements were made through cashier's check or were bank service charges.
- 7. We scanned each 2008 restricted fund disbursement recorded on Form 31-M for evidence that it represented a transfer from the restricted fund to any other state or county political party, which Ohio Rev. Code 3517(X)(4) prohibits. We found no evidence of any transfers.
- 8. We compared the purpose of each disbursement listed on 2008 Disbursement Forms 31-M to the purpose listed on the vendor invoice and to the purposes Ohio Rev. Code Section 3517.18 permits. We found no instances where the purpose described on the invoice violated the restrictions of Ohio Rev. Code Section 3517.18

We were not engaged to, and did not examine each *Statement of Political Party Restricted Fund Deposits* and *Statement of Political Party Restricted Fund Disbursements* filed for 2008, the objective of which would have been to opine on compliance. Accordingly, we do not express an opinion. Had we performed additional procedures, other matters might have come to our attention that we would have reported to you.
