#### INDEPENDENT ACCOUNTANT'S REPORT

We have examined the Carrollton Exempted Village School District, Carroll County, management's assertion that the census data and pensionable wages reported to the School Employees Retirement System as of June 30, 2021, and for the year then ended was accurate and complete.
