INDEPENDENT AUDITOR'S REPORT ON COMPLIANCE WITH REQUIREMENTS OF THE MEDICAID PROGRAM APPLICABLE TO SELECT PHYSICAL THERAPY SERVICES

We examined Drayer Physical Therapy - Northern Ohio LLC's (the Provider's) compliance with specified Medicaid requirements for provider qualifications, service documentation and service authorization related to the provision of physical therapy services during the period of January 1, 2018 through December 31, 2019.

The Provider entered into an agreement (the Provider Agreement) with the Ohio Department of Medicaid (ODM) to provide services to Medicaid recipients and to adhere to the terms of the agreement, state statutes and rules, federal statutes and rules, including the duty to maintain records supporting claims for payments made by Ohio Medicaid. The Provider is responsible for compliance with the specified requirements. Our responsibility is to express an opinion on the Provider's compliance with the specified Medicaid requirements based on our examination.

We tested compliance with Ohio Admin. Code §§ 5160-8-31 and 5160-8-35 which require physical therapy providers to hold a valid Ohio license and Ohio Admin. Code § 5160-1-17.2 which specifies that an individual practitioner, owner, director, officer or employee of the provider cannot be currently subject to sanction or otherwise prohibited from providing services. We found no non-compliance with these provider qualifications.

We selected a random sample of physical therapy services (procedure code 97110) and then selected all of the additional therapy services provided to the same recipient on the same date (procedure codes 97112, 97140 and 97530). In total we examined 490 services and found that the service documentation contained the services performed, start and ending times (duration) and supported the Medicaid payment as required by Ohio Admin. Code § 5160-1-27 and that the services were authorized by a treatment plan as required by Ohio Admin. Code §§ 5160-8-33 and 5160-8-35.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. Those standards require that we plan and perform the examination to obtain reasonable assurance about whether the Provider complied, in all material respects, with the specified requirements referenced above. An examination involves performing procedures to obtain evidence about whether the Provider complied with the specified requirements. The nature, timing and extent of the procedures selected depend on our judgment, including an assessment of the risks of material noncompliance, whether due to fraud or error. We believe the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion. Our examination does not provide a legal determination on the Provider's compliance with the specified requirements.

Internal Control over Compliance

The Provider is responsible for establishing and maintaining effective internal control over compliance with the Medicaid requirements. We did not perform any test of the internal controls and we did not rely on the internal controls in determining our examination procedures. Accordingly, we do not express an opinion on the effectiveness of the Provider's internal control over compliance.

Opinion on Compliance

In our opinion, the Provider complied, in all material respects, with the aforementioned requirements for physical therapy services for the period of January 1, 2018 through December 31, 2019.

Our testing was limited to the specified Medicaid requirements for provider qualifications, service documentation and service authorization. We did not test other requirements and, accordingly, we do not express an opinion on the Provider's compliance with other requirements.

This report is intended solely for the information and use of the Provider, the ODM and other regulatory and oversight bodies, and is not intended to be, and should not be used by anyone other than these specified parties.
