## **BASIC AUDIT REPORT**

West Milton Community Improvement Corporation Miami County 701 South Miami Street West Milton, Ohio 45383

We have completed certain procedures in accordance with Ohio Rev. Code Section 117.01(G) to the accounting records and related documents of the West Milton Community Improvement Corporation, Miami County, (the Corporation) for the years ended December 31, 2020 and 2019.

Our procedures were designed solely to satisfy the audit requirements of Ohio Rev. Code Section 117.11(A). Because our procedures were not designed to opine on the Corporation's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the Corporation's financial statements, transactions or balances for the years ended December 31, 2020 and 2019.

The Corporation's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code Section 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found the following significant compliance or accounting issues to report.

#### **Current Year Observations**

1. Ohio Rev. Code § 149.43(E)(2) states that "all public offices shall adopt a public records policy in compliance with this section for responding to public records requests. In adopting a public records policy under this division, a public office may obtain guidance from the model public records policy developed and provided to the public office by the attorney general under section 109.43 of the Revised Code. Except as otherwise provided in this section, the policy may not limit the number of public records that the public office will make available to a single person, may not limit the number of public records that it will make available during a fixed period of time, and may not establish a fixed period of time before it will respond to a request for inspection or copying of public records, unless that period is less than eight hours. The public office shall distribute the public records policy adopted by the public office under this division to the employee of the public office who is the records custodian or records manager or otherwise has custody of the records of that office. The public office shall require that employee to acknowledge receipt of the copy of the public records policy.

The public office shall create a poster that describes its public records policy and shall post the poster in a conspicuous place in the public office and in all locations where the public office has branch offices. The public office may post its public records policy on the internet web site of the public office if the public office maintains an internet web site. A public office that has established a manual or handbook of its general policies and procedures for all employees of the public office shall include the public records policy of the public office in the manual or handbook."

There was no evidence that a formal public records policy had been adopted by the Corporation.

## **Current Year Observations (Continued)**

The Corporation should adopt a public records policy and post it in accordance with the requirements shown above. The Corporation can refer to the model policy on the Attorney General's website.

2. Ohio Rev. Code § 149.43(B)(2) states, in part, that "a public office also shall have available a copy of its current records retention schedule at a location readily available to the public."

There was no evidence that a formal records retention schedule had been adopted by the Corporation. Failure to adopt a records retention schedule could lead to Corporation records being destroyed prior to what is allowable by law or against the Board's wishes.

The Corporation should adopt a formal records retention schedule and make it available to the public.

## **Current Status of Matter Reported in our Prior Engagement**

1. Ohio Rev. Code § 1724.05 requires, in part, the Corporation to file an annual report with the auditor of state within 120 days after the Corporation's fiscal year-end. However, the Corporation's 2020 and 2019 annual report filing requirements were met with an alternate Hinkle System financial statement/disclosure report filed July 14, 2021 and August 2, 2021 respectively, which was significantly after the required due dates. The Corporation should implement procedures to ensure that the annual financial report is filed prior to the reporting deadline. Failure to do so could result in cancellation of articles of incorporation. A similar matter was also identified in our prior engagement.
