#### **BASIC AUDIT REPORT**

Community Improvement Corporation of Washington Fayette County Washington Court House, Ohio 43160

We have completed certain procedures in accordance with Ohio Rev. Code Section 117.01(G) to the accounting records and related documents of the Community Improvement Corporation of Washington, Fayette County, (the Corporation) for the years ended December 31, 2021 and 2020.

Our procedures were designed solely to satisfy the audit requirements of Ohio Rev. Code Section 117.11(A). Because our procedures were not designed to opine on the Corporation's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the Corporation's financial statements, transactions or balances for the years ended December 31, 2021 and 2020.

The Corporation's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code Section 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found the following significant compliance or accounting issues to report.

#### **Current Year Observations**

1. Ohio Rev. Code § 149.43(E)(2) further requires all public offices take certain actions with regard to their public record policy. Public offices must distribute their Public Records Policy to the employee who is the records custodian/manager or otherwise has custody of the records of that office and have that employee acknowledge receipt of the Public Records Policy.

The Corporation did not distribute their Public Records Policy to the employee who is the records custodian/manager and obtain acknowledgement of receipt.

The policy shall be distributed to the records custodian/manager and the Corporation should have a written acknowledgement of receipt from the records custodian/manager.

## **Current Status of Matters Reported in our Prior Engagement**

Our prior audit for the years ended December 31, 2018, and 2019 included an observation noting the Corporation did not have a Public Records Policy or Records Retention Policy in place as required by ORC 149.43(E)(2). This observation was corrected.

Our prior report also included, an observation noting the Corporation was not making timely deposits. This observation was corrected.
