BASIC AUDIT REPORT

We have completed certain procedures in accordance with Ohio Rev. Code § 117.01(G) to the accounting records and related documents of the Springfield Township Community Improvement Corporation, Hamilton County, Ohio (the Corporation), for the years ended December 31, 2024 and 2023.

Our procedures were designed solely to satisfy the audit requirements of Ohio Rev. Code § 117.11(A). Because our procedures were not designed to opine on the Corporation's financial statements, we did not follow *generally accepted auditing standards*. We do not provide any assurance on the Corporation's financial statements, transactions or balances for the years ended December 31, 2024 and 2023.

The Corporation's management is responsible for preparing and maintaining its accounting records and related documents. Our responsibility under Ohio Rev. Code § 117.11(A) is to examine, analyze and inspect these records and documents.

Based on the results of our procedures, we found no significant compliance or accounting issues to report.

Current Status of Matters Reported in our Prior Engagement

1. The prior management letter for the audit of years ended December 31, 2022 and 2021 identified the lack of a public records policy. The Corporation has created a public records policy in accordance with Ohio Rev. Code § 149.43(E)(2).
2. The prior management letter for the audit of years ended December 31, 2022 and 2021 identified the lack of a records retention schedule. The Corporation has created a records retention schedule in accordance with Ohio Rev. Code § 149.43(B)(2).
3. The prior management letter for the audit of years ended December 31, 2022 and 2021 identified that one member of the Board of Directors failed to complete a Fraud Risk Assessment Questionnaire. No matters were noted during the current engagement.
