

## Corporate Credit Cards

- Minimal or no supporting documentation for charges (for example, summary charge slips vs. detailed receipts)
- Unexplained increases in credit-card usage
- No or minimal policies regarding access and use
- No or unreasonably high limits
- No restrictions on types of purchases
- Inappropriate charges noted on statements
